I, Patricia B. Baum, hereby state the following:

1. I am the Court-appointed lead plaintiff in the above-captioned shareholder class action (the "Action"). I submit this declaration in support of the settlement of the Action. I have personal knowledge of the matters referred to herein.

2. Based on my familiarity with the case, review of significant documents filed in the case, and my extensive communications with lead counsel, I believe I am in a good position to comment on the settlement and request for attorneys' fees. I believe that the \$28 million recovery in this case is very good. I understand the difficulty of proving these cases at trial and understand that even in a strong case the class could recover nothing. I also appreciate that a settlement now guarantees that the class members will be paid an additional premium on top of the Harman acquisition price. On these grounds, and others, I fully support the settlement.

3. In addition, based on my regular communications with counsel and my review of the documents filed in this case, I believe that lead counsel should be awarded their requested fee of 31% of the settlement amount along with their expenses (not to exceed \$200,000). I understand that lead counsel has been paid nothing to date and has expended significant amount of time and money on this matter. In my opinion, lead counsel did an excellent job on this case.
